NOTICE OF CANCELLATION OF SPECIAL TAX LIEN

**Capistrano Unified School District
Community Facilities District No. 94-1**

The Capistrano Unified School District ("CUSD"), County of Orange, State of California, with respect to the CUSD's Community Facilities District No. 94-1 ("CFD"), previously formed the CFD and authorized the levy of certain special taxes pursuant to the provisions of the Mello-Roos Community Facilities Act of 1982.

NOTICE IS HEREBY GIVEN that:

1. The Board of Trustees of CUSD has determined that the obligation to pay the special taxes heretofore levied by CUSD within the CFD has been permanently satisfied, and CUSD will no longer levy and collect special taxes with respect to the certain parcels of real properties identified in Exhibit "A" attached hereto and incorporated herein by this reference ("Properties").
2. The Notice of Special Tax Lien, filed by CUSD with respect to the CFD on August 19, 1997, in the Office of the County Recorder of the County of Orange as Document No. 19970399189, is hereby cancelled with respect to the Properties.
3. Upon recordation of this Notice of Cancellation of Special Tax Lien, the special tax imposed on the Properties by CUSD is hereby extinguished as to the Properties. The recordation of this Notice of Cancellation of Special Tax Lien will not dissolve the CFD.

The recording of this Notice of Cancellation of Special Tax Lien is authorized and directed pursuant to Section 53344 of the *California Government Code*.
