INSTRUCTIONS FOR PRESENTATIONS TO THE BOARD BY PARENTS AND CITIZENS PRESENT AT THIS MEETING

We are pleased you can be with us at this meeting, and we hope you will return often. Your visit assures us of continuing community interest in our schools.

The members of the Board of Trustees of this District are locally elected state officials, who serve four-year terms of office, and who are responsible for the educational program of our community from grades kindergarten through twelve. They are required to conduct programs of the schools in accordance with the State of California Constitution, the State Education Code, and other laws relating to schools enacted by the Legislature, and policies and procedures which this Board adopts.

The Board is a policy-making body whose actions are guided by the school district's Mission and Goals. Administration of the District is delegated to a professional administrative staff headed by the Superintendent.

The agenda and its extensive background material are studied by each member of the Board for at least two days preceding the meeting. Board Members can call the administrative staff for clarification on any item, and many of the items on the agenda were discussed by the Board during previous meetings. These procedures enable the Board to act more effectively on agenda items than would otherwise be possible.

WHAT TO DO IF YOU WISH TO ADDRESS THE BOARD OF TRUSTEES

ITEMS ON THE AGENDA. Any person may address the Board concerning any item on the agenda and may, at the discretion of the Board, be granted three (3) minutes to make a presentation to the Board at the time a specific item is under discussion. However, the time assigned for individual presentations could be fewer than three (3) minutes depending upon the total number of speakers who wish to address a specific agenda topic. Prior to the opening of the meeting, a Request to Address the Board card (located in the foyer) should be completed and submitted to the Secretary of the Board. The total time devoted to presentations to the Board shall not exceed twenty (20) minutes, unless additional time is granted by the Board. All presentations shall be heard by the Board prior to the formal discussion of the agenda topic under consideration. Once an agenda item has been opened for public comment, no additional "Request to Address the Board of Trustees" cards shall be accepted for that topic.

ORAL COMMUNICATIONS (Non-Agenda Items). Citizens may address the Board on any item not appearing on the agenda. Individual presentations are limited to three (3) minutes per individual, with twenty (20) minutes in total being devoted for this purpose, but could be less if there are a large number of Oral Communication speakers. Legally, the Board may not take action on items raised by speakers under Oral Communications. However, at its discretion, the Board may refer items to the administration for follow-up or place topics on a future Board agenda.

PUBLIC HEARINGS. Anytime the Board schedules a separate public hearing on any given topic, it shall not hear speakers on that topic before the public hearing, except as to the scheduling of the hearing, nor shall it hear speakers after the hearing, except as to changes in the policy or recommended actions which are directed at the time of the hearing.

CLOSED SESSION. In accordance with Education Code §35146 and Government Code §54957, the Board may recess to Closed Session to discuss personnel matters which they consider inadvisable to take up in a public meeting.

REASONABLE ACCOMMODATION

In order to help ensure participation in the meeting of disabled individuals, appropriate disability-related accommodations or modifications shall be provided by the Board, upon request, in accordance with the Americans with Disabilities Act (ADA). Persons with a disability who require a disability-related accommodation or modification, including auxiliary aids and services in order to participate in a Board meeting, shall contact the Superintendent or designee in writing by noon on the Friday before the scheduled meeting. Such notification shall provide school district personnel time to make reasonable arrangements to assure accessibility to the meeting.

APPROVAL OF SUBSTITUTE TEACHER DAILY RATE OF PAY INCREASE

BACKGROUND INFORMATION

A substitute teacher shortage is occurring throughout the state of California. Part of the reason is certificated teachers are now more likely to get teaching positions with the improving economy and many "baby boomers" are retiring. Several substitute jobs go unfilled daily, requiring teachers to cover other teachers' classes and, at times, combine classes to ensure coverage. In order to address the shortage, the Personnel Department continues to post openings for substitutes throughout the year, and holds orientations monthly in order to acquaint new substitutes within the District's schools and systems. The District currently employs 651 substitute teachers.

The rate of pay for the District substitute teachers has not increased in more than fifteen years, and recently several veteran substitutes have sent letters or have simply resigned, citing insufficient pay as the reason. The District substitutes currently receive the lowest *daily* rate of pay and highest *long term* rate of pay of districts surveyed in the county. A comparison with neighboring districts that compete for the shrinking substitute teacher pool is as follows:

CURRENT CONSIDERATIONS

Raising the daily rate for substitute teachers to \$105 per day would make the District more competitive with neighboring districts, encouraging local substitutes to serve in their own district. The increase in daily rate would ultimately be offset by decreasing the long term rate. Decreasing the long term rate would also benefit the District teachers who are out for an extended period of time. When teachers are on extended leaves and run out of sick pay, they pay the differential between substitute teacher costs and their pay.

FINANCIAL IMPLICATIONS

There is an estimated cost for 2015-2016 of \$126,000 associated with this action.

EXHIBIT 2

STAFF RECOMMENDATION

It is recommended the Board of Trustees approve the action to change the substitute teacher pay rate to a two-tiered system that aligns with two-tiered systems in most Orange County districts. Modify the long term rate so it aligns with current credentialing requirements for general education long term substitutes. A substitute would be deemed "long term" when he/she had been in the classroom 30 days. The long term rate, even when reduced, remains competitive locally. Phase in these changes so current substitutes will experience an increase in the current year, but none will experience a decrease in 2015-2016:

Proposed for 2015-2016: Daily rate and hourly rate to be implemented February 1, 2016 at an estimated cost of \$126,000.00. The long term daily rate would be implemented effective July 1, 2016.
