**BACKGROUND INFORMATION**

California *Education Code (EC)* Section 56205 requires the submission of Annual Budget and Service Plans that are adopted at public hearings held by the special education local plan area (SELPA). These plans must identify expected expenditures and include a description of services, the physical location of the services, and must demonstrate that all individuals with exceptional needs have access to services and instruction appropriate to meet their needs as specified in their individualized education program. The Capistrano Unified School District Board of Trustees review and approve the plans annually after a public hearing.

**CURRENT CONSIDERATIONS**

Each SELPA must adopt the Annual Service Plan and Annual Budget according to the governance and policy making process established in the local plan. The local plan calls for the Board of Trustees after a public hearing to adopt the Annual Plan and Annual Budget. The Annual Budget Plan identifies the expected expenditures for all items required to service the students with exceptional needs in the SELPA. The Annual Service Plan describes the full continuum of service options to be provided within the SELPA assuring access to appropriate instruction and services for all students with disabilities from birth to twenty-two years of age, including children with low-incidence disabilities.

**FINANCIAL IMPLICATIONS**

The Annual Service Plan and Budget identify the expected expenditures to service students with exceptional needs in the District. Allocated federal, state, and general funds will be utilized to ensure services and instruction. Anticipated expenditures for the 2021-2022 school year are \$110,159,952.

**STAFF RECOMMENDATION**

It is recommended the Board of Trustees approve the Annual Service Plan and Annual Budget Plan.
