**ADDENDUM TO APPROVED 2011 INITIAL STUDY/MITIGATED NEGATIVE
DECLARATION FOR THE COMPRESSED NATURAL GAS DISPENSER AT
THE ALISO VIEJO TRANSPORTATION CENTER**

WHEREAS, the Capistrano Unified School District (District) is a public school district duly formed under the laws the State of California; and

WHEREAS, the District is the lead agency pursuant to the California Environmental Quality Act (CEQA); and

WHEREAS, the District has the responsibility and duty to provide adequate educational facilities in accordance with State law for students and staff members to facilitate academic, social, emotional and personal growth; and

WHEREAS, the Initial Study/Mitigated Negative Declaration (IS/MND) for the established Compressed Natural Gas (CNG) fueling station at 2B Liberty Drive was approved by the Board of Trustees in November 2011; and

WHEREAS, the Board of Trustees directed staff to evaluate the installation of an additional 20 fueling hoses at the District's transportation center; and

WHEREAS, staff prepared an Addendum to the approved 2011 IS/MND to evaluate the installation of 20 additional fueling hoses to the District's transportation center, thereby increasing the number of fueling hoses from 20 to 40; and

WHEREAS, the Addendum to the approved 2011 IS/MND was prepared pursuant to the requirements of CEQA § 15164, to identify the minor additions associated with the Compressed Natural Gas fueling station; and

WHEREAS, District staff recommended the Board adopt the Addendum to the approved 2011 IS/MND as complete and adequate; and

WHEREAS, the Board of Trustees reviewed all environmental documentation comprising the Addendum and finds the Addendum considers all minor technical changes and additions to the approved 2011 IS/MND, and is complete and adequate, and fully complies with all requirements of CEQA; and

WHEREAS, District staff and the District's CEQA consultant have recommended the Board find this Addendum adequate and complete, and adopt it in compliance with CEQA; and

NOW, THEREFORE, BE IT RESOLVED the Board of Trustees of Capistrano Unified School District hereby adopts the following findings regarding the Addendum prepared for the 20 additional fueling CNG hoses:

1. The Board of Trustees certifies that the Addendum was prepared in compliance with the requirements of CEQA and the CEQA Guidelines;
2. That, based upon the evidence submitted and demonstrated through the analysis included in the Addendum, none of the conditions described in §15162 or §15163 of the CEQA Guidelines requiring for the preparation of a subsequent or supplement EIR or negative declaration have occurred;
3. The Addendum reflects the Board of Trustee's independent judgment and analysis;
4. The Board of Trustees finds no substantial evidence has been presented which would vitiate the facts and conclusion in the Addendum;
5. The Board of Trustees determines that the Addendum satisfies all the requirements of CEQA and are adequate to serve as the required environmental documentation for the proposed installation of 20 additional fueling hoses to the District's CNG fueling station, and therefore, hereby approves and adopts the Addendum;
