**RESOLUTION TO DESIGNATE THE OBSERVANCE OF THE STATE LINCOLN DAY
HOLIDAY DURING THE 2021-2022, 2022-2023, and 2023-2024 CALENDARS TO
ALIGN WITH FEDERAL WASHINGTON DAY HOLIDAY**

WHEREAS, Education Code section 37220 provides public schools shall close on specific holidays including Lincoln Day and Washington Day. Section 37220 provides that Lincoln Day shall be observed on the Monday or Friday of the week in which February 12 occurs and Washington Day shall be observed on the third Monday in February; and

WHEREAS, Education Code section 37220(e) allows for District Boards, by Resolution, to set the date upon which the District's schools close in observance of any of the holidays listed in Education Code section 37220(a), with the exception of Veteran's Day; and

WHEREAS, the District has, traditionally, taken these holidays together to make a four-day weekend in February; and


WHEREAS, for the 2021-2022, 2022-2023, and 2023-2024 school years, the District wishes to designate the observance of the holiday known as Lincoln Day on February 18, 2022, February 17, 2023, and February 16, 2024, respectively, to coincide with Washington Day and extended the weekend break for students and staff;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Board of Trustees of the Capistrano Unified School District approves the observance of, and school closures on, the holiday known as Lincoln Day on Friday February 18, 2022, Friday, February 17, 2023, and Friday, February 16, 2024, as set forth in the calendars for the 2021-2022, 2022-2023, and 2023-2024 school years.

The foregoing Resolution was **PASSED** and **ADOPTED** at a regular meeting of the Governing Board of the Capistrano Unified School District on the 3rd day of March, 2021 by the following vote:


