The Governing Board of the Capistrano Unified School District has engaged the services of ESS advisers Dr. Suzette Lovely and Dr. Joseph Farley to conduct the search for the district's next superintendent. Below is an overview of the process, timelines, and activities that will occur between March and June 2023:

Engagement Phase – March 8 – April 12, 2023	
Planning Meeting with Governing Board March 8, 2023	Search advisers discuss search process, timelines and communication plans with the governing board. The board identifies applicant qualifications/experience along with stakeholder and community groups in which the consultants should gather input.
Stakeholder Input	Search advisers meet with groups to identify CUSD's strengths, issues/needs, and desired qualities and characteristics of the next superintendent. An online survey and regional community forums are utilized to gather additional input from parents, students, employees, and the community at large.
Presentation of Leadership Profile Report April 19, 2023	Search advisers present a leadership profile report to the board summarizing stakeholder input. The board establishes any additional selection criteria to attract candidates that best match stakeholder interests and district needs.
Activation Phase* – March 13 – April 23, 2023 *Overlaps w/Engagement Phase	
Job Posting Opens: March 13, 2023 Closes: April 8, 2023	Superintendent vacancy is posted in a variety of sources, including EDJOIN, EdCAL (print & on-line publication)
Recruitment	ESS advisers utilize an array of regional, state and national networks to actively recruit, correspond with, and screen qualified candidates who possess the requisite experiences and most closely match the leadership profile.

Reference Checks	ESS advisers contact candidate references and conduct in-depth appraisals on each applicant, including press coverage and social media reviews.
Selection Phase – April 24–June 15, 2023	
Review Candidate Slate  May 3, 2023 Closed Session	Board meets with ESS advisers in closed session to review applications and determine the best qualified candidates to invite for interviews.
First Level Interviews Friday, May 19, 2023 Closed Session	First round interviews are conducted by the governing board.
Second Level Interviews  Saturday, May 20, 2023  Closed Session	Second round interviews with a select number of finalists are conducted by the governing board.
Due Diligence Review	Search advisers engage a 3 <sup>rd</sup> party screener to conduct extensive background checks on the finalist including: criminal; civil; credit; education; and online history.
Validation Visit  Week of May 22 <sup>nd</sup>	Board members will visit the workplace of the preferred candidate. ESS advisers will assist trustees and the finalist in scheduling this visit.
Announcement of the Board's Preferred Candidate  Week of May 22 <sup>nd</sup>	Following the Validation Visit, due diligence review, and successful negotiation of an employment contract, a press release is distributed to announce the name of the finalist pending board approval.
Employment of the New Superintendent May 31, 2023	The board takes formal action to employ the new superintendent in closed session and introduces the candidate to the community in open session.
June 14, 2023	The new superintendent's employment contract is approved by the governing board.
Transition Phase – July 1 - August 2023	
Arrival and Transition of New Superintendent	ESS advisers provide a facilitated transition meeting with the new superintendent and governing board to share information learned throughout the search process.
