Administrator Introductions/Discussion

Clint Collins, Asst. Superintendent, Special Education Services-

- Ms. Varricchio from DJAMS will present to other middle school principals like what she
 presented today.
- ESY Locations, dates and times are now confirmed and will be posted to the Special Ed website next week
- Transition IEP's will be starting over the next few weeks
- Steps will be part of RH Dana K-5 next year.
- ENF will be rebranded as an Early Childhood Center. All types of preschools will be located there, and the center will be used as a diagnostic center. This is similar to diagnostic centers other districts already have in place. This will help for better placement.
- Questions were asked by attendees and answered.

Jeana Dagley, Executive Director of Special Education Programs and Related Services, SELPA Dir.-

• Special education credentialing has changed recently, and bridge credentials will be available for already credentialed teachers. CAPO will be offering these to all our

teachers in phases, starting with preschool and elementary teachers. It consists of a 1 day training then teachers applying for the bridge credential.

- o Early childhood credential –bridge covers TK and K which are not covered currently in their credentials.
- Mild-moderate and moderate -severe credentials- the bridge will broaden disabilities that they cover.
- Alternate pathway to a diploma was presented. Pathway is defined by the state and is available for those who are eligible to take the CAA. This will be available to CAPO students starting next year. IEP team needs to hold an IEP by end of Freshman year to confirm a decision of a pathway to an alternate diploma. Students choosing this path will still be eligible for ATP.

- Resource Fair for those transitioning out of ATP, however recommend for all ages, will be held March 9 from 5:30-7pm in the CUSD board room.
- There will be a Positive Parenting Workshop for elementary age families.

- Gigi's Playhouse is now opened in Laguna Hills for people with Down Syndrome. Wonderful center and many activities for all ages are provided.

Michele Ploessel-Campbell - Legislative Update-

State Senator Anthony Portantino has introduced bill SB691 that will mandate dyslexia screening annually for all students in K-2 unless parents opt their children out.
