LEAD GROUNDSKEEPER

DEFINITION

Under general direction, plan, organize, schedule, and supervise the grounds maintenance crews of a high school and feeder schools, including crews performing gardening and groundskeeping, grounds equipment maintenance and operation, and tree trimming; may perform duties of Grounds Maintenance Worker.

EXAMPLES OF DUTIES

The following duties are typical for this classification. Incumbents may not perform all of the listed duties and/or may be required to perform additional or different duties from those set forth below to address business needs and changing business practices.

- 1. Schedules, coordinates, and may participate in the activities of employees performing a variety of grounds maintenance functions.
- 2. Inspects school grounds including playground areas, to ensure safety of structure and terrain.
- 3. Assists and meets with management in setting priorities for District-wide grounds maintenance activities.
- 4. Assists with evaluating employee performance.
- 5. Arranges for the purchase of nursery stock and other gardening materials.
- 6. Estimates costs of labor and materials; coordinates work with outside contractors.
- 7. Interprets landscape blueprints.
- 8. Evaluates and assists in the selection of gardening supplies and equipment.
- 9. Assists with the District's pesticide and herbicide application program.
- 10. Conducts monthly safety meetings per the District IIPP.
- 11. Performs other related duties as required.

QUALIFICATIONS

Knowledge of:

Principles, methods, techniques, materials, and tools pertaining to grounds maintenance; landscape design; varieties of fertilizers and their proper use; plant diseases and pests common to the area and methods used in their eradication and control.

Ability to:

Operate tractors, trucks, and other heavy grounds maintenance equipment; plan, organize, train, and supervise the work of others; estimate the cost of labor and materials; meet changing priorities and weather conditions, and respond to staff and public concerns regarding chemicals used and trees being trimmed or removed; operate a computer to access District's central irrigation timers and process work orders; understand and carry out oral and written instructions; establish and maintain cooperative working relationships; comply with the District's customer service standards, as outlined in Board policy.

Education/Experience:

Any combination equivalent to: Graduation from high school; and three years experience in grounds maintenance including the operation of grounds equipment. Lead or supervisory experience desired.

License/Certificate Requirement:

Possession of a valid Class C California Driver's License; must remain insurable at the standard insurance market rate.
