- 1. If you would like to keep all of your current Health Benefits and have no changes, there is nothing you need to do. Your 2021 Health Benefits will roll over. If you have Dependent Care or FSA, these will not roll over. You will need to go into the American Fidelity website to make your FSA and Dependent Care election for 2022. In addition, there have been several plan enhancements and rate changes for 2022. Please read the enclosed information carefully.
- 2. There will be no in-person Informational Meetings or one-on-one meetings with an AF representative this year. There are virtual resources available to you, including virtual meetings (see dates below) and a new Open Enrollment virtual platform. Flyers will be made available to you with details.
