

Capistrano Unified School District 2024-25 BUS PASS APPLICATION

A bus pass application must be completed for each student. The Bus Pass Office will begin accepting applications June 3, 2024 for the 2024-25 school year. Applications **MUST BE SUBMITTED NO LATER THAN 1:00pm on JUNE 28, 2024** to guarantee issuance before the first day of school. Applications will be processed in the order received, on a first come, first serve basis. Although the Transportation Department will make every effort to process each application and provide every student with a bus pass, some schools have very limited bus seating capacity available. Students who do not receive a pass due to over capacity will be placed on a wait list in the order received. Unfortunately, if an application is submitted after June 28, Transportation cannot guarantee a bus pass will be issued in time for the first day of school. Please make sure your child brings the bus pass to the bus stop every day. All applications are subject to bus stop review.

NOTE: CUSD does not provide bus service for School of Choice. Parents must transport.

Free and/or Reduced Fare Passes

To qualify for a Free or Reduced Fare bus pass, families must be income eligible. Families applying for a Free or Reduced Fare pass must submit proof in the form of a letter from the Capistrano Unified Food and Nutrition Services Department, deeming them eligible for Free or Reduced services. If submitted by June 28, 2024, a letter from the prior school year will be deemed sufficient. Beginning July 1, 2024 a current letter will be required. By submitting an application for a Free or Reduced Fare bus pass, you are certifying your household meets the Federal Income requirements for Free or Reduced rate services. All applications are subject to verification. If it is deemed the student has not used their bus pass for 10 consecutive school days, it may be cancelled and the student's seat on the bus forfeited.
